

CONDITIONS ANNEXED TO AND FORMING PART OF LAND USE PERMIT: G08H004

PART A: SCOPE OF LAND USE PERMIT

1. This Land Use Permit entitles "**Gwich'in Tribal Council**" to conduct the following activities:

To operate and maintain a Wellness Camp located on Gwich'in private lands at 68 16 02 N 135 46 20 W on the west side of the East Branch of the Mackenzie River approximately 10.4 kilometres south-southwest of Inuvik NT.

The camp includes the main building (approx 400 m²), a power generating plant (approx 60 m²), a water treatment plant (approx 30 m²), a water purification plant (approx 30 m²), and a living quarters for the Camp Maintainer (approx 50 m²).

The camp also has a diesel fuel storage facility with a capacity of 35,000 litres and three (3) 4,500 litre propane tanks.

2. This Land Use Permit is issued subject to the conditions contained herein with respect to the use of land for the activities and area identified in Part A, Item 1 of this Land Use Permit.
3. Compliance with the terms and conditions of this Land Use Permit does not absolve the Permittee from responsibility for compliance with the requirements of all applicable Federal, Territorial and Municipal legislation.

PART B: DEFINITIONS

"Act" means the Mackenzie Valley Resource Management Act.

"Board" means the Gwich'in Land and Water Board established under Part 3 of the Mackenzie Valley Resource Management Act.

"Land Use Inspector" means an Inspector designated by the Minister under the Mackenzie Valley Resource Management Act.

"Sewage" means all toilet wastes and grey water.

"Sewage Disposal Facilities" means sump(s) and/or sewage collection tank(s) designed to hold sewage.

PART C: CONDITIONS OF PERMIT

26 (1) (A) THE LOCATION AND AREA OF LANDS THAT MAY BE USED IN THIS LAND-USE OPERATION

1. The Permittee shall not conduct this land use operation on any lands not designated in the accepted application, unless otherwise authorized in writing by the Board.
2. The Permittee shall not conduct any part of this land use operation within three hundred (300) metres of any privately owned land or structure, unless otherwise authorized in writing by a Land Use Inspector.

3. The Permittee's Field Supervisor shall contact or meet with a Land Use Inspector at the Inuvik office of the Department of Indian Affairs and Northern Development, - (867) 777-3361 - and the Gwich'in Land and Water Board, - (867) 777-7960 - at least forty-eight (48) hours prior to the commencement of this land use operation.
4. The Permittee shall advise a Land Use Inspector and the Board at least ten (10) days prior to the completion of this land use operation of:
(a) the plan for removal or storage of equipment and materials; and
(b) when final clean-up and restoration of the land used will be completed.
5. The Permittee shall provide, in writing, to a Land Use Inspector and the Board, at least forty-eight (48) hours prior to commencement of this land use operation, the following information:
(a) person, or persons, in charge of the field operation to whom notices, orders, and reports may be served;
(b) alternates; and
(c) all methods for contacting the above person(s).

6. The Permittee shall submit a progress report to a Land Use Inspector and the Board every six (6) months during the course of this land use operation.

PROGRESS

7. The Board, for the purpose of this land use operation, designates March 31st as spring break-up, unless otherwise authorized in writing by a Land Use Inspector.

8. The Land Use Inspector and/or the Board reserve the right to impose closure of any area to the Permittee in periods when dangers to natural resources are severe.

CLOSURE

9. The Permittee shall not use any equipment except of the type, size, and number that is listed in the accepted application, unless otherwise authorized in writing by a Land Use Inspector.
10. The Permittee shall not place dirt or debris into streams to serve as ramps for loading or unloading ships or barges, unless authorized in writing by a Land Use Inspector.
11. The Permittee shall ensure garbage containers are on site.
