Item Description:	The Gwich'in Land and Water Board (the Board) intends to consider, on its own initiative, a one-year renewal of the Government of the Northwest territories Department of Infrastructure (GNWT INF)'s Water Licences G15L8-001 and G15L8-002, pursuant to subparagraph 36(1)(a)(ii) of the Waters Act. The proposed renewals would carry over the terms and conditions of these existing Licences, with no changes except to the expiry date, which would be updated to November 30, 2021. These renewals are being considered due to extenuating circumstances resulting from the COVID-19 pandemic, as the applicant has been unable to fulfill the requirements of a new Water Licence Application.
