Hi Angela,

Rick Olsen just gave me a copy of Gus's amended Timber Cutting Permit that was approved Dec.3/04, so I'll fax a copy over to you shortly using a copy of this e-mail as a cover page.

Gus has to pay the advance fee of \$2,120.75 to RWED first though, and as of last Friday when I last talked to him last, he still hadn't mailed you the required \$600 LUP fees. He's aware that if he misses your Dec. 7th deadline, that his LUP appl. can't be tabled at the mid-Dec. MV Board Meeting, so will then have to wait till the next meeting in mid-January/05.

That's the latest from this end.

Talk to you soon.

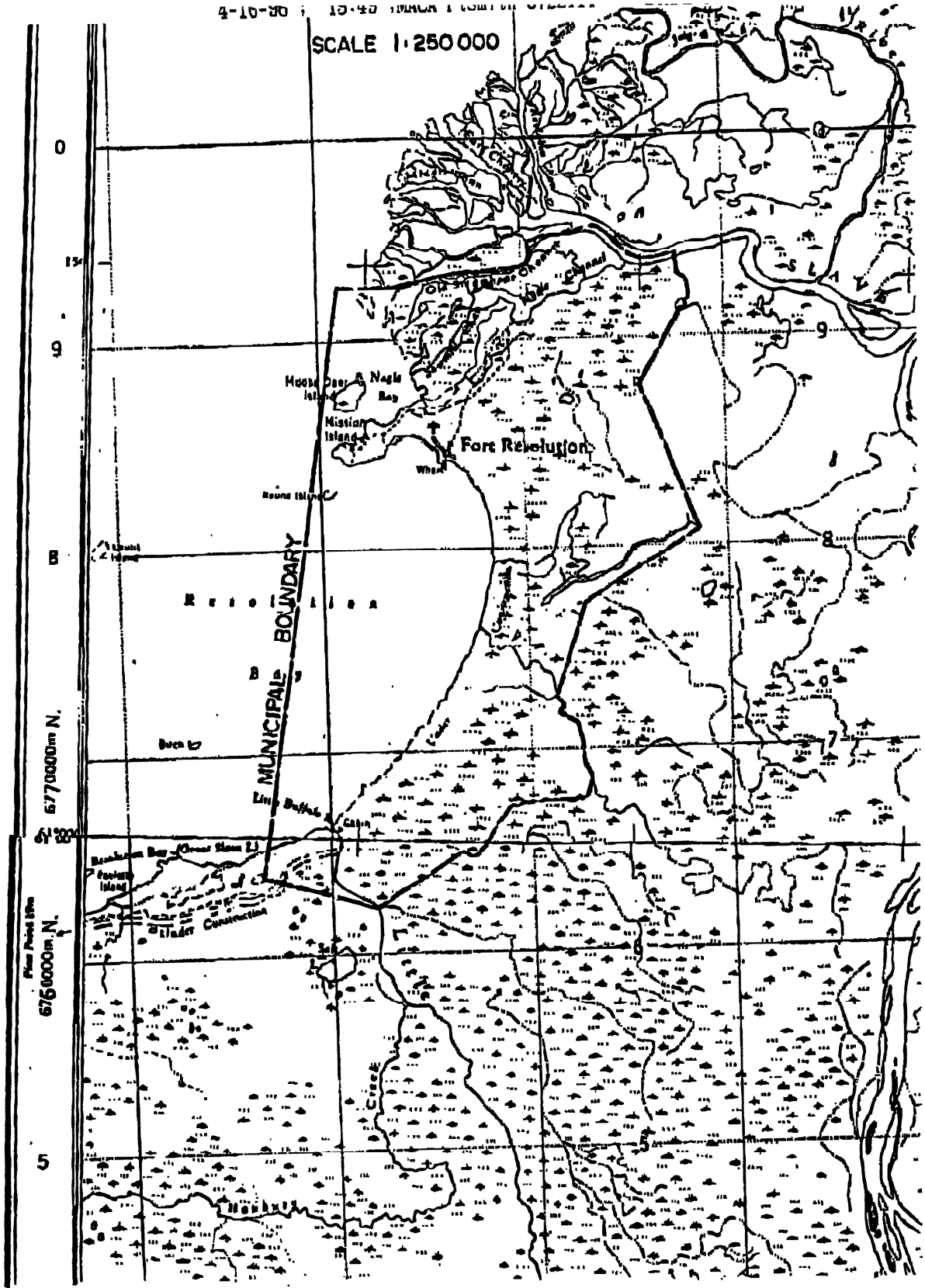
