Final Plan Request

From the land use records in this office, it is noted that Land Use Permit MV2004W0041 will expire on January 15, 2009. Prior to the expiry date of this Permit, full restoration, clean up and removal of equipment, materials, building, etc., must be completed.

Should you require additional time to complete your land use operation, please refer to section 26(6) of the Mackenzie Valley Land Use Regulations (MVLUR) regarding extensions to the duration of a permit. An extension request of not more than two (2) years must be received before the expiry date of the Permit.

If an extension is not requested, you are required to submit a Final Plan within sixty (60) days of expiry, pursuant to section 29 of the Mackenzie Valley Land Use Regulations. This must include the following:

1. A map, normally at a scale of 1:50,000 showing your location, area, and distances of all land use operations. Sketches are acceptable, but all maps must have the north indicator, scale, and coordinates clearly marked;
2. A summary of the hectares utilized in each aspect of the land use operation; and
3. A calculation of land use fees.

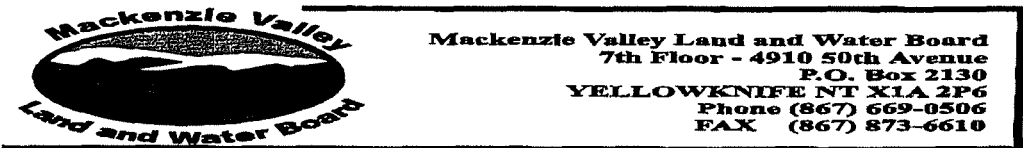
