The full cooperation of Deninu K'ue Development Corp. is anticipated and appreciated.

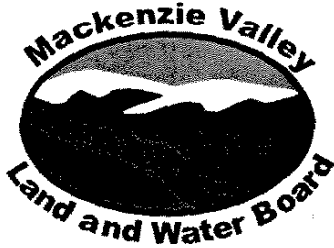

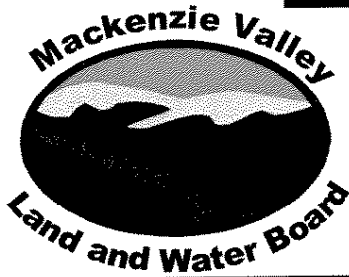
