Robert – as we discussed please find attached the revised cover page for the Gahcho kue water licence. I would request that you forward this to the appropriate people

Hopefully it addresses the concerns over the lack of an expiry date on the cover page included with the original transmittal.

As was explained in the reasons for decision of the Board that was attached to the licence when transmitted to the Minister; the Board had decided on a 14 year term, and was proposing to fill in the date once the effective date was determined (post Ministerial sign off).

However, this seems to be of concern to the GNWT.

To address this concern we have included an end date to the licence that should be very close to the 14 year term once approved by the Minister.

However, the Board would appreciate the opportunity to discuss this administrative issue in the near future to find the best mechanism to implement the Board's decision in a clear and reasonable way.
