Hi Kerry,

Thank you for your letter of September 3, 2019 in which you ask about the expected steps to be included in the Board's Directive for considering Claims for Water Compensation; specifically, whether there will be an opportunity for parties to issue Information Requests to another party. At this time, in advance of the September 26 deadline for Claims for Compensation to be submitted, the Board has not yet decided on the final process and timelines for hearing Claims for Water Compensation. That said, as with all Board proceedings, it will be carried out to ensure it meets the requirements of procedural fairness, as well as being efficient, focussed, and meeting the needs of the parties involved.

In preparing the City's Claim(s) you are reminded that Claimants and the Giant Mine Remediation Project (GMRP) Team are expected to make best efforts to negotiate a settlement and advise the Board of the results of these efforts as part of any Claim submitted. At that time, any information you feel has not been provided by the GMRP Team through prior meetings could be requested in your Claim Form(s).

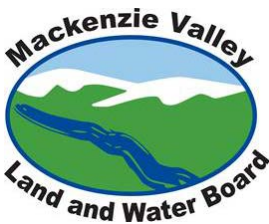
