Dr. Ketan Shankardass, Assistant Professor at the University of Wilfred Laurier University, with areas of expertise in chronic stress, and environmental health, has been contracted by the Giant Mine Remediation Project to develop a scope of work for stress effects. This evaluation is a component of a larger comprehensive quantitative Human Health Risk Assessment (HHRA) which will be commissioned by an independent, qualified human health assessor, anticipated for spring 2016.

Dr.Shankardass will be visiting Yellowknife January 26th to 28th to conduct focus groups to provide input that will help him design the Scope of Work for the stress component of the HHRA. We'd like to organize a public session with any interested community members on Wednesday, January 27th. We are offering both an option of an afternoon session from 1pm-4pm and an evening session from 6pm-9pm in order to accommodate everyone's busy schedules.

The session will involve a short presentation from Dr. Shankardass on the framework and proposed approach that he will use as a basis to create the Scope of Work. The discussion with you will include developing a list of perceived stressors and identifying some community resources that could potential help alleviate effects on stress.

This is an opportunity for you to provide direct input to the Project. Both the Giant Mine Project Team and Dr.Shankardass are very interested in hearing from you.
