Please note that although this application is for a renewal, a new file number has been assigned – MV2009L3-0005. Please refer to this number in future correspondence.

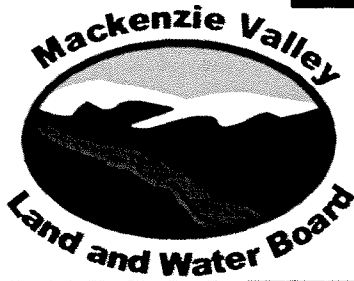
