However, we have placed your comments on the Public Registry in keeping with our information review policy which states:

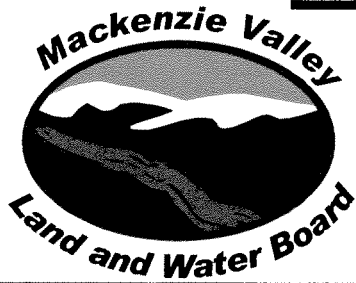
