Hi Miki,

Thank you for the board approval of this Study and the recommendations. The City is committed to working with the Inspector to make sure that appropriate locations are chosen for new SNP stations to ensure complete monitoring of the surrounding area.

However, as you are well aware, this summer has been an extremely busy one for us here at the City and that is likely to continue on well into Autumn. Given this fact, as well as the fact that these two new Surveillance Network Program sites will not be included in the sampling program until next Spring, the City requests that a deadline for the proposal for the revision of the SNP be pushed back until later in the year. A November 30th, 2014 deadline would allow ample time for the City to work with the Inspector to choose locations and prepare a complete report on the proposed changes and the rationale behind them.

Please consider this request to postpone the deadline and let me know if it will be possible.
