
However, we will place your comments on the Public Registry in keeping with our information review policy which states:

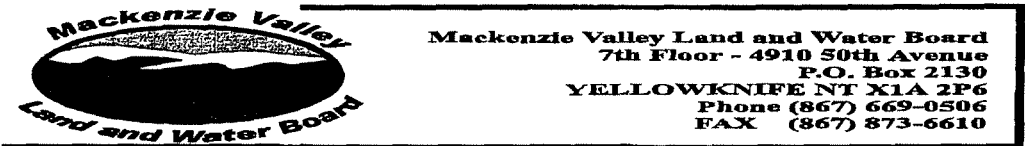
