**Water Licence Amendment Application – Incomplete  
Municipal - Hamlet of Ft. Liard**

Your Water Licence Amendment Application, received on July 7, 2010, has been reviewed and found to be lacking sufficient information to conduct a preliminary screening. In order for this application to be considered complete and forwarded for review, the following information must be submitted to our office:

1. An application fee of \$30.00 made out to the Receiver General for Canada as per section 7 of the Northwest Territories Waters Regulations;
2. More detailed community involvement information with respect to the proposed solid waste facility; and
3. Corrected figure numbers in Appendix C. The figure numbers cited in the Application do not match up with the Figures in Appendix C.

A land use permit application may be required, as the proposed solid waste facility is located outside of the Hamlet of Fort Liard's local government boundaries. Please refer to sections 4 and 5 of the Mackenzie Valley Land Use Regulations for the triggers.

This supplementary information must be provided within 90 days; otherwise it will be assumed that you do not wish to continue the processing of your application. Upon receipt of this information, the application will be reviewed in accordance with the *Mackenzie Valley Resource Management Act* and the *Northwest Territories Waters Act*.
