Hi Angela,

The only comment that DFO has is in reference to the water intake screen (C3). Through previous discussions with the Town of Fort Smith, it was reported that the implementation of these guidelines were not practical for the intake at the Slave River. The town is currently using a ½" mesh screen due to an abundance of debris at the source. Guidelines are not always applicable and site specific review is often required. DFO recommends that the reference to these guidelines be removed. Instead there could be reference to the ½" screen that has been implemented to avoid being clogged with debris while still providing protection for fish in the area.
