> I spoke to site and a biologist. Site has bird deterrence measures are in place. Site has photo's going back years of Ravens' flocking on the roaster after the breeding season is complete. This will include juveniles fledged this year. It is common in most corvids. Ravens like to use the highest feature to flock. The behaviour is not tied to feeding, although there may be incidental feeding during this period, it is low risk.
