The Mackenzie Valley Land and Water Board reviewed the file for Land Use Permit (Permit) MV2013C0002 on September 17, 2020.

Final Plan

The Board received a Final Plan for this land-use operation on July 24, 2020.¹ Subsequently, an Inspector recommended closure of the file.² The Board has approved the Final Plan, as it fulfills the requirements set out in subsections 29(1) and 29(2), and section 30 of the Mackenzie Valley Land Use Regulations (MVLUR).

Fees

The Board notes application fees were submitted in the amount of \$150.00 (Receipt #C154565³), which are non-refundable. Having considered the Final Plan, the Board has verified the land-use fees pursuant to 31(1) of the MVLUR for this land-use operation as follows:
