Please forward this email letter requesting the extension of our Land Use Permits for Mackay Lake Lodge and Warburton Bay Lodge

please note that True North Safaris Ltd has management control and responsibility for the lodges and Malcolm Jaeb is the President and Gary Jaeb is GM.

Please also consider that our tourism and accommodation and meal services at our lodges are an ongoing activity and will continue to be unless/until the lodges are closed permanently

We ask that the GNWT and Boards responsible for the LUP consider that tourism lodges are not subject to the same time frames as mining exploration camps and mines

We have also asked in the past that we be allowed to use environmentally friendly home made incinerators and be allowed to use left over fuels as accelerants and use minor oil spills as dust deprecants on our runway.

Since the LUP are coming up for review and extensions, it may be a good time to consider these other issues
