I got an email from you/someone during the application process that advised me to make sure that the Board members got my point of view so i asked Miki to do this as i do not know how to forward info to the members.

I was then told that my input had been put on the public registry, however, it now appears that the Board members did not get to consider my concerns, only recommendations from staff with the drafted conditions that are now in the permit. This seems to undermine the Board's role and our concern, as the applicant, that we would get a fair hearing.  
Please advise.

This especially relates to the permit requirement that we transport garbage back to Yellowknife and have it incinerated here..Our argument is that we will incur unnecessary expenses and burn more fossil fuel, infecting the environment, only to have them burned at another location ..that we cannot use accelerants to burn garbage and we must transport fuel and ashes back to a licensed facilities.

Throughout the process I asked for information about who are the licensed facilities and how one can get a license and I got no response other than told to check the yellow pages. Please provide this information.

We did provide a waste management plan and spill contingency plan but the permit makes no reference to these but require that we submit plans in a few months. Please explain this.

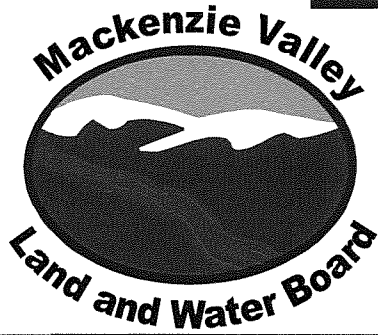
The Board has provided reasons for decision and responded to follow up questions. This is my final response on this issue.

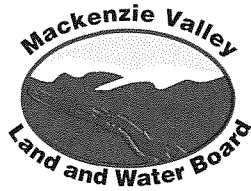

**MV2013J0006 – True North Safaris Ltd. – Type A Land Use Permit**

Your email dated October 15, 2013 was brought to my attention and I would like to respond to the concerns you have raised.

The members of the Mackenzie Valley Land and Water Board (the Board) carefully reviewed all the correspondence submitted by True North Safaris Ltd. (TNS) during the permitting process. The Board considered these submissions, as well as the staff report, when making our decision on the terms and conditions for the land use permit issued to TNS.


The Board became involved in this file earlier this summer when we directed Board staff to organize a meeting to discuss issues that had come forward in the review of the Land Use Permit (LUP) application. The Board's intention was that the meeting provide an opportunity for TNS to work with reviewers to better understand regulatory requirements and find the simplest ways to ensure TNS would be able to meet these requirements.

In response to your question regarding licenced facilities, a licenced facility is one which has been issued a Water Licence under the authority of the *Northwest Territories Waters Act*. A Water Licence authorizes the use of waters and/or disposal of waste, as per the terms and conditions attached to the authorization. Examples of licenced facilities include landfills operated by the City of Yellowknife and the community of Dettah.

The Waste Management Plan that was submitted with the application included practices that are not acceptable to the Board. Rather than require TNS to submit a revised Waste Management Plan, the Board chose terms and conditions for the LUP that clearly define acceptable waste management practices. A revised Spill Contingency Plan (SCP) is required to address the site-specific spill contingency needs and practices at Mackay Lake Lodge. Details on the updates required for the SCP were included in the issuance letter dated September 24, 2013.
