Good day Gary,

Inspectors do not have the authority to amend permit conditions as our role is to enforce the permit and regulations. The authority to amend Land Use Permit MV2013J0006 can only be authorized by the Mackenzie Valley Land & Water Board. For your reference, Section 26(2) of the *Mackenzie Valley Land Use Regulations* allows for permit amendments by the Board and states:

· **26(2)** Subject to subsections (4) and (5), the Board may amend any of the conditions of a permit on receipt of a written request from the permittee setting out

(a) the conditions that the permittee wishes to have amended;

(b) the nature of the proposed amendment; and

(c) the reasons for the proposed amendment.

You may contact the Mackenzie Valley Land & Water Board directly to initiate the amendment process for LUP MV2013J0006.
