North American Corporation Ltd. (NATCL) – Cantung Mine  
Application for Water Licence MV2015L2-0003 (renewal)

### 1) Introductions

### 2) Update on current status of NATCL

- NATCL provided a short update on their current status under the *Companies Creditors Arrangements Act* (CCAA). July 9, 2015 is the 30-day deadline for negotiation under the CCAA and NATCL plans to request an extension until July 19, 2015.
- There have been many layoffs at the mine site and the underground is minimally staffed.
- The environmental division remains staffed at full strength and specific funding has been requested to fulfill their environmental regulatory requirements.
- NATCL has 4 more months of ore stockpiled at site and anticipates having adequate funding until October 15, 2015.
- NATCL is arranging for funding to complete the assessment of liquefaction potential of Tailings Pond 4 this summer; after which they will apply to the MVLWB to reduce the amount of reclamation security required for this facility.
- In fall 2015 NATCL anticipates entering care and maintenance mode. They will be able to confirm this in August 2015.
- Parties should provide evidence to the Board in their written interventions regarding this proceeding given these financial

circumstances and the Section 26(5)(d) requirement under the *Mackenzie Valley Resource Management Act*.

3) Hearing structure and format

- a. Dates and Locations will be confirmed based on the information parties present in their written interventions. Planned dates are: August 26 and 27, at the Tree of Peace in Yellowknife, NT
- b. Teleconference line will be available; please contact ROs if anticipating you will need the line
- c. Translation and transcription will be available
- d. Agenda will be fluid until written interventions are received
- e. The company will present first, followed by a questioning period by all parties
- f. Interveners will then present, followed by a questioning period by all parties
- g. Number of Participants, time required for presentation:
