RE: Land Use Permit MV2008QU0035 Hwy 1 km 191.1 Renewal

The Deh Gah Gotie First Nations (DGGFN) have been informed from the proponent Rowe's Construction that they were in the process of re applying to the existing licence for it to be renewed. In order to support the proponent's application the DGGFN want the conditions attached to the licence;

1. Hire local people
2. Supply local band membership with granular resources with a 10% discount.

The DGGFN would like to re iterate the Mackenzie Valley Land and Water Board of the Interim Measures Agreement which states

20 states;

(a) New permits may be issued on the withdrawn land under the *Territorial Quarrying Regulations* only;


- (i) for sources of material which had been opened prior to the dates of the withdrawal orders
- (ii) for new sources of material required for essential community construction purposes;
- (iii) with the consent of the Deh Cho First Nations; or
- (iv) in cases where, in the opinion of the Minister of DIAND, no alternative sources of supply is reasonably available in the surrounding area and after consultation with the Deh Cho First Nations.

(b) No new leases may be issued on the withdrawn land under *the Territorial Quarrying Regulations*.
