On October 20, 2016 The Mackenzie Valley Land and Water Board decided to invoke paragraph 22(2)(b) of the Mackenzie Valley Land Use Regulations to allow additional time to complete further studies on lands used in the land use operation under LUP Application MV2016C0030. This will allow the Land Use Permit and Water Licence Amendment Applications to be reviewed concurrently. The reviewer comment deadline on the Water Licence Amendment (MV2013L2-0005) and Land Use Permit (MV2016C0030) Applications has been extended to November 30, 2016.
