Bullmoose-Ruth Remediation Project (the BMR Project) – Follow-up

Mackenzie Valley Land and Water Board (MVLWB or the Board) staff received a response from INAC-CARD on September 28, 2016 relating to the concerns raised in your September 14, 2016 letter and your subsequent response on October 4, 2016.

At this stage in the regulatory review process for the BMR Project, the Board has directed staff to send the draft Land Use Permit (Permit) and Water Licence (Licence) out for review. Please consider the draft Permit and Licence conditions during your ongoing discussions with INAC-CARD. If you have recommendations on the draft Permit and Licence conditions that would mitigate your concerns, please provide those recommendations and any outstanding concerns, along with rationale, to Board staff by the review deadline.

Upon receipt of this information, Board staff will continue to process the Applications and a determination will be made by the Board. The Board encourages the ongoing dialogue between the NSMA and INAC-CARD.
