1. Purpose/Report Summary

The purpose of this Report is to notify the Mackenzie Valley Land and Water Board (MVLWB/the Board) that Dominion Diamonds Holdings Limited has changed its name to Dominion Diamond Mines ULC.

2. Background

- July 6, 2017 – Issuance of Land Use Permit (Permit) MV2017C0022;
- January 15, 2018 – Notification of name change received;
- **February 22, 2018 – Notification presented to the Board; and**
- July 5, 2022 – Expiry of Permit MV2017C0022.

3. Discussion

On July 6, 2017, the Board issued Permit MV2017C0022 to Dominion Diamond Holdings Limited for preliminary and advanced exploration activities throughout the Glowworm Lake area, including prospecting, geochemical and geophysical surveys to determine the source of Kimberlite Indicator Minerals (KIM) and airborne geophysical anomalies, and reverse circulation drilling.

On January 15, 2018, notification of the name change from Dominion Diamonds Holdings Limited to Dominion Diamond Mines ULC was submitted to the Board (attached). This included several certificates of the amalgamation of the companies and registration with the Government of the Northwest Territories Corporate Registries Office.

4. Comments

Name changes do not require Board approval, however, new cover pages and conditions reflecting the change need to be issued.

5. Reviewer Comments

Not applicable – name changes are not distributed for review.

6. Security

The GNWT currently holds \$89,000.00 held in security for Permit MV2017C0022 (attached).

7. Conclusion

Board staff have not identified any concerns associated with this name change.

8. Recommendation


