1. Purpose/Report Summary

The purpose of this Report is to notify the Mackenzie Valley Land and Water Board (MVLWB/the Board) that Darnley Bay Resources Limited has changed its name to Pine Point Mining Limited.

2. Background

- February 16, 2017 Land Use Permit (Permit) MV2016C0023 assigned from Pine Point Holding Corp. to Darnley Bay Resources Ltd.;
- July 20, 2017 Land Use Permit MV2017C0024 issued to Darnley Bay Resources Ltd.;
- September 1, 2017 Notification of name change received;
- September 7, 2017 Certificate of Amendment of Registration received;
- September 28, 2017 Name change presented to Board;
- December 28, 2021 Expiry of Permit MV2016C0023; and
- July 19, 2022 Expiry of Permit MV2017C0024.

3. Discussion

Darnley Bay Resources Limited currently holds two Land Use Permits issued by the Board – MV2016C0023, and MV2017C0024. Darnley Bay Resources Limited has changed its name to Pine Point Mining Limited (attached).

4. Comments

Name changes do not require Board approval, however, new cover pages and conditions reflecting the change need to be issued. There are no other authorizations under the jurisdiction of the Board, aside from the two above-mentioned Permits, which will be affected by the name change.

5. Reviewer Comments

Not applicable – name changes are not distributed for review.

6. Security

There is \$30,000.00 in security held under Permit MV2016C0023 (attached). Permit MV2017C0024 requires \$164,500.00, which had not been paid to Government of the Northwest Territories (GNWT) at the time of writing this Staff report. Security is required to be paid prior to the start of any activities associated with a permit. Board staff have notified GNWT of the name change (attached).

7. Conclusion

Board staff have not identified any concerns associated with this name change.

8. Recommendation

Board staff recommend that the Board acknowledges the name change and that Land Use Permits MV2016C0023 and MV2017C0024 be updated to reflect the company name change from Darnley Bay Resources Limited to Pine Point Mining Limited.
