**Type A Land Use Permit Application – Complete
Mineral Exploration - Pine Point Area, NT**

The Mackenzie Valley Land and Water Board (MVLWB) received your Application for a land use permit on May 29, 2017. Your Application will be processed under paragraph 22(1)(b) of the Mackenzie Valley Land Use Regulations (MVLUR).

Within forty-two (42) days of the date of this letter, the MVLWB will take one of the following actions:

1. Issue a Type A permit, subject to any conditions included under subsection 26(1) of the MVLUR;
2. Order, under section 24 of the *Mackenzie Valley Resource Management Act* (MVRMA), that a hearing be held or further studies or investigations be made respecting the lands proposed to be used in the land-use operation;
3. Refer the Application to the Mackenzie Valley Environmental Impact Review Board (MVEIRB) for an environmental assessment under subsection 125(1) of the Act; or
4. Where a requirement set out in section 61 or 62 of the MVRMA has not been met or for any other reason as provided for in legislation, refuse to issue a permit.
