Hi Katherine.

Thank you for the information.

The proposed works will now occur during the Arctic Grayling spawning cycle. Although the proposed works are not intended to occur in water, Arctic Grayling are sensitive to disturbance and constitute a protected fishery in Baker Creek. Care must therefore be taken to ensure that these works do not adversely affect the spawning cycle.

DFO is encouraged by the proposed Mitigation and Monitoring provisions. DFO suggests the following provisions as well.

1. A qualified biologist be on site at all times during the construction phase. The biologist would have two main roles:
  - a. Monitoring for sediment flux into Baker Creek.
  - b. Monitoring for signs that construction is affecting Arctic Grayling migration. Signs could include Arctic Grayling congregating below the construction site in an area not typically considered spawning grounds, instead of continuing upstream.
2. Construction be halted immediately if Arctic Grayling migration is affected.
3. Construction be halted immediately if sediment from the site enters Baker Creek. Construction remain on hold until such time as the issue as the sediment source can be stabilized and the issue mitigated.
4. Construction be halted immediately if water levels encroach on the construction site until such time as the water level subsides to a safe level.

My regulatory colleagues have expressed interest in a site visit to review the mitigation measures prior to the open water season. Please let me know if we can make those arrangements.
