Paramount Resources Ltd. ("Paramount") has received the necessary regulatory approvals from the Office of the Regulator of Oil and Gas Operations ("OROGO") and the Mackenzie Valley Land and Water Board ("MVLWB") for an abandonment program in the Liard East and Celibeta Project areas. Paramount plans on undertaking the program in the 2019-2020 winter season. The program would include opening access from Fort Liard east to the locations, the furthest of which is the Celibeta H-78 well. The other location Paramount plans on accessing is J-76. Paramount plans on abandoning both the H-78 and J-76 wells.
