Updated List and Contact Information for TerraX Minerals Inc.'s Yellowknife City Gold Projects' Potentially Affected and Other Interested Parties as at Oct 15, 2018 Version 6.1

This information was originally submitted on February 12, 2014 in preparation for an application for a Land Use Permit for the Northbelt and subsequently approved as TerraX's Forward Looking Engagement Plan Draft 3.0 following multiple rounds of consultation in 2013 and early 2014. At the time it was noted that due to staff turnover, the anticipated devolution of responsibilities from the Government of Canada to the Government of the Northwest Territories, expected government reorganization and the continuing development of engagement protocols among affected parties that the Appendices to the Forward Looking Engagement Plan and contacts would need to be updated.

The Forward Looking Engagement Plan's Appendices were updated during the summer of 2016 in preparation for an application for a Land Use Permit for the South Belt by contacting and consulting with the potentially affected parties. Draft 4.0 was circulated to the potentially affected parties for any additional updates in August 2016 resulting in the Draft 5.1. Draft 5.1 was submitted to the MVLWB on November 10th, 2016 and subsequently approved.

Version 5.1 was updated by over 50 engagements and contacts including: phone, e-mail, internet research and discussions in April and May 2018 resulting in 6.0. Version 6.0 was shared with all stakeholders on June 1, 2018 via e-mail which explained the purpose of the update, provided a copy of 6.0 and invited corrections.

As of October 15, 2018 16 written updates and corrections were received, as were confirmations that the information remains correct. In addition there were a number of less formal responses with corrections, amendments or confirmations.

The Forward Looking Engagement Plan is a living document and will continue to be updated as circumstances require.
