**Information Request- Porritt Landing Dredging Project**

Thank you for your information request of August 10, 2018. Currently the parcel identified to receive the dredged materials is under the administration and control of the Department of Lands and is deemed Commissioner's Land.

Lands has no issue with utilization of the parcel (Lot 1057, Plan 977) for this purpose, however testing by the proponent (the Town of Hay River) for contamination of the dredged material **must** take place. On examination of the results by the GNWT, Lands will determine if the dredged material can remain, or if results are returned that indicate the material has contamination, then it will need to be disposed of at an authorized facility.
