Mackenzie Valley Land and Water Board - De Beers Canada Inc. - Snap Lake Mine - Type A Water Licence MV2019L2-0004 - Acceptance of Security Deposit

The Government of the Northwest Territories (GNWT), Department of Environment and Natural Resources (ENR) formally acknowledges receipt of an original Standby Letter of Credit (ILOC) dated August 21, 2020 for the amount \$3,349,589.00 which was issued by the Royal Bank of Canada on behalf of De Beers Canada Inc. On August 28, 2020, the ILOC was received by the GNWT.

The security deposit is required under Part C, Item 1 and Schedule 2, Item 1 of the Water Licence. The security deposit is acceptable to the GNWT as prescribed by Section 35. (1) of the *Waters Act* and Section 11. (3) of the *Waters Regulations*.

Currently, GNWT – ENR holds \$31,194,253.00 in security deposits for the noted Type A Water Licence. The security deposit is further described in Attachment 1 – Summary Table.

The security deposit is held in safekeeping by the Assistant Comptroller General and Superintendent of Insurance, Department of Finance.
