#### Subject:

Engagement Plan (Version 2.0) for the Norman Wells Airport Property Landfarm submitted by Transport Canada, Prairie and Northern Region - Environmental Services, Contaminated Sites for Board approval.

## 1. Purpose/Report Summary

The purpose of this Report is to present to the Sahtu Land and Water Board for consideration:

- a) Engagement Plan Version 2.0;
- b) Summary of stakeholder review comments and Proponent responses.

#### 2. Background

- October 18, 2017 Transport Canada, Prairie and Northern Region Environmental Services, Contaminated Sites (TC) submitted an Engagement Letter outlining their proposal to install new groundwater monitoring wells at the Norman Wells Airport, Land Treatment Unit and application for a Land Use Permit;
- November 8, 2017 TC submitted their Engagement Record and Plan Version 1.0;
- December 5, 2017 Type A Land Use Permit S17X-004 was issued to TC for installation (drilling) of three
   (3) groundwater monitoring wells around an existing Hydrocarbon Soil Contaminated Soil Treatment
   Facility (Landfarm) within municipal boundaries at the Norman Wells Airport. Type B Water Licence
   S17L8-003 was also issued and associated with the operation, maintenance, closure and reclamation of
   the Landfarm;
- April 12, 2018 the Sahtu Land & Water Board (SLWB or Board) received a revised Engagement Plan (Version 2.0) and an updated consultation letter with groundwater well installation location map;
- April 13, 2018 Review packages were sent out electronically to members of the Tulita District Distribution List using the Online Review System with a request for comments by May 8, 2018;
- May 8, 2018 Reviewer comments received and deadline;
- May 15, 2018 Proponent response deadline and received; and
- May 28, 2018 Presentation to the Board for decision.

#### 3. Discussion

## 3.1 Project Overview

As previously described in <u>Staff Report 1</u> (Application Review), in 2003 Transport Canada commissioned construction of a Land Treatment Unit (Hydrocarbon Contaminated Soil Treatment Facility or Landfarm) as part of a remediation project associated with divestment of the Norman Wells Airport property to the Government of the Northwest Territories. The supporting documentation submitted with the November 14, 2017 water licence application provided information related to the construction and maintenance of the Landfarm with limited details on the progress of treatment of the hydrocarbon contaminated soil. The Landfarm will be undergoing decommissioning once the soil quality meets the applicable criteria. Treated soils will be deposited at the site and re-graded.

Transport Canada has submitted Version 2.0 of its **Engagement Plan** for the Norman Wells Airport Hydrocarbon Contaminated Soil Treatment Facility (Landfarm) Project in accordance with Board Direction in the December 5, 2017 Issuance Letter for Licence S17L8-003 and Permit S17X-004:

The Board requires immediate submission of an Engagement Plan and Record; which considers the "life of project" and meets the basic requirements of the Board's Engagement Guidelines for Applicants and Holders of Water Licences and Land Use Permits (2014) for approval by February 5, 2018.

An extension of the submission deadline of February 5, 2018 to April 16, 2018 had been granted by Board staff on March 12, 2018. This submission requires Board approval.

## 3.2 Process Requirements

TC submitted a revised <u>Engagement Plan (Version 2.0)</u> in accordance with Part B (General Conditions), Condition 12 of License S17L8-003 which states:

The Licensee shall act in accordance with the Engagement Plan submitted to Board on November 8, 2017, once approved.

Of the 31 organizations to which the plan was distributed, seventeen (17) are represented within the Sahtu Settlement Area. Review comments were received from:

- GNWT Department of Environment and Natural Resources (ENR); and
- Sahtu Renewable Resources Board (SRRB).

#### 4.0 Comments

Board staff have completed a conformity check of the Engagement Plan and Record (Version 2.0) against the Board's Engagement and Consultation Policy (the Policy) and the Engagement Guidelines for Applicants and Holders of Water Licences and Land Use Permits (the Guidelines). As a result of this conformity check (Table 1), Board staff have recommended that the Plan meets the criteria of the policy.

In addition to the Policy assessment tool, the Engagement Guidelines outlines six (6) components that an Engagement Plan must satisfy in order to be considered complete. Board staff has conducted a conformity check to ensure the Plan satisfies these requirements (Table 2).

  - The Department of Environment and Natural Resources (ENR), Government of the Northwest Territories has reviewed the plan at reference based on its mandated responsibilities under the Environmental Protection Act, the Forest Management Act, the Forest Protection Act, the Species at Risk (NWT) Act, the Waters Act and the Wildlife Act and has no comments or recommendations for the consideration of the Board at this time.
- Sahtu Renewable Resources Board (SRRB):
  - o No comments or recommendations at this time.

There were no comments or recommendations from reviewers for the proponent to respond to.

#### 6. Conclusion

The revised Engagement Plan (Version 2.0) submitted by BluMetric Environmental on behalf on Transport Canada satisfies the requirements of the Board's *Engagement and Consultation Policy* (the Policy) and the *Engagement Guidelines for Applicants and Holders of Water Licences and Land Use Permits* (the Guidelines).

There were no significant reviewer comments recommending further revisions to the Plan.
