As the land-use operation covers a 15 day period, please accept the following notification:

- a) All equipment (trucks and drill rig) shall be removed from the site upon completion of drilling in each community within the above noted time frames. No materials or equipment will be stored in the communities beyond the duration of this program.
- b) Final cleanup will occur prior to departure from each community within the above noted time frames. There is no anticipated generation of waste while on site. Drilling is being done via auger with no drilling mud. The material produced will be only soil. The material being pulled up will be spread out in order to maintain the appearance of the site.
