Dear Mike Magrum,

Re: Storage Authorization at Itchen and Point Lake area, NT

According to our records, the Storage Authorization for Land Use Permit W2010C0005 expires on September 13, 2019. Prior to the expiry of the Storage Authorization for this Permit, the Permittee is required to:

1. Complete the removal of all buildings, fuel, and equipment, pursuant to subsection 16(1) of the Mackenzie Valley Land Use Regulations and restore the permit area, pursuant to section 15 of the Mackenzie Valley Land Use Regulations; or
2. Obtain a new land use permit from the WLWB.

Pursuant to subsection 16(3.1) of the Mackenzie Valley Land Use Regulations, the Permittee cannot request another storage authorization because this was the second one-year Storage Authorization issued for Permit W2010C0005.

Please confirm that all fuel/materials stored at the Itchen/Point Lake area have been removed from site. Alternatively, please let us know if the Permittee intends to apply for a new land use permit.
