Hello Ellen,

Please be advised that with the issuance of the above mentioned land use permit, comes an increase in the security required. The new permit requires a security of \$59,000 and the old permit MV2004C0036 has \$18,000 posted on it. Prior to recommending final clearance on the old permit, the difference of \$41,000 dollars must be posted with Aboriginal Affairs and Northern Development Canada. This amount must be posted immediately as New Nadina has the Monument Camp, large quantities of fuel and equipment stored in the land use area.
