ASSIGNMENT AND EXTENSION OF A TYPE "A" LAND USE PERMIT W2011C0005

Attached is Land Use Permit No. W2011C0005 issued by the Wek'èezhìi Land and Water Board (WLWB) in accordance with the *Mackenzie Valley Resource Management Act*. Under subsection 38 of the Mackenzie Valley Land Use Regulations, this Permit is hereby assigned from Peregrine Exploration Ltd. to Peregrine Diamonds Ltd. effective December 9, 2016. All obligations outlined within the terms and conditions of this Permit are now transferred to Peregrine Diamonds Ltd., including restoration and cleanup of the activities previously authorized under this Permit.

Under subsection 26 of the Mackenzie Valley Land Use Regulations, this Permit is hereby issued a two year extension with an expiry of January 9, 2019.

Please read all conditions carefully and note that as per Land Use Permit Condition #46, the security deposit in the amount of \$106,000.00 shall be posted with the Government of the Northwest Territories, Department of Lands, North Slave Region, #16 Yellowknife Airport, Yellowknife, NT, X1A 3T2. Please send a copy of the security deposit receipt to the WLWB office prior to the commencement of operations in the Lac de Gras area.

Please be advised that this letter, with attached procedures, all inspection reports, and correspondence related thereto, are part of the Public Registry, and are intended to keep all interested parties informed of the manner in which the Permit requirements are being met. All Public Registry material will be considered if an amendment to the Permit is requested.

CONDITIONS ANNEXED TO AND FORMING PART OF LAND USE PERMIT NUMBER W2011C0005

Part A: Scope of Permit

1. This permit entitles Peregrine Diamonds Ltd. to conduct the following activities:
 - a) Mineral exploration including the establishment of camps, diamond drilling, large diameter reverse circulation drilling, winter road construction and maintenance, and fuel storage in the DO-27 Lake area, NT.
 - b) Min. Latitude: 64°18'1.962" Max. Lat. 64°20'47.3172"
Min. Long. 109°46'58.4004" Max. Long. 109°51'31.3164"
2. The Permit is issued subject to the conditions contained herein with respect to the use of land for the activities and area identified in Part A, Item 1 of this permit.
3. Compliance with the terms and conditions of this permit does not absolve the Permittee from responsibility for compliance with the requirements of all applicable Federal, Territorial, Tlicho, and Municipal legislation.

Part B: Definitions

“**Act**” means the *Mackenzie Valley Resource Management Act*;

“**Artesian Aquifer**” means a water-bearing stratum, which when encountered during drilling operations, produces a pressurized flow of groundwater that reaches an elevation above the ground surface;

“**Board**” means the Wek'èezhii Land and Water Board established under Part 4 of the *Mackenzie Valley Resource Management Act*;

“**Drill Waste**” means all materials or chemicals, solid or liquid, associated with the drilling of boreholes and includes borehole cuttings;

“**Inspector**” means an Inspector designated by the Minister under the *Mackenzie Valley Resource Management Act*;



“**Sump**” means a man-made pit, trench hollow or cavity in the earth's surface used for the purpose of depositing waste material therein;

“**Watercourse**” means a natural body of flowing or standing water or an area occupied by water during part of the year, and includes streams, springs, swamps and gulches but does not include groundwater.
