**Final Plan Request – Winter Road Access at North Arm Park and Egress off Great Slave Lake, NT**

From our land use records, Land Use Permit W2013F0003 expires on October 9, 2018. Prior to the expiry date of this permit, restoration, clean up and removal of equipment, materials, building, etc., must be completed.

Should you require additional time to complete your land use operation, refer to subsection 26(6) of the Mackenzie Valley Land Use Regulations regarding extensions to a land use permit. An extension request of not more than two (2) years must be received before the expiry date of the permit. If an extension of the permit is not requested, pursuant to subsection 29 of the Mackenzie Valley Land Use Regulations, you are required to submit a Final Plan within sixty (60) days of expiry including:

1. A map, normally at a scale of 1:50,000 showing your location, area, and distances of all land use operations. Sketches are acceptable but all maps must have the north indicator, scale and coordinates clearly marked.
2. A summary of the hectares utilized in each aspect of the land use operation; and
3. A calculation of land use fees.
