Re: Fortune Minerals Limited – Letter of Clearance – Staging Area – Hislop Lake, NT

The Wek'èezhii Land and Water Board (WLWB or the Board) reviewed the file for Land Use Permit (Permit) W2013T0008 on January 14, 2021.

Final Plan

The Board received a Final Plan for this land-use operation on December 21, 2020.¹ Subsequently, an Inspector recommended closure of the file.² The Board has accepted the Final Plan, as it fulfills the requirements set out in subsections 29(1) and 29(2), and section 30 of the Mackenzie Valley Land Use Regulations (MVLUR).

Fees

The Board notes application fees were submitted in the amount of \$150.00 (Receipt #C148413³), which are non-refundable. Having considered the Final Plan, the Board has verified the land-use fees pursuant to 31(1) of the MVLUR for this land-use operation as follows:
