Explanatory Remarks - Wind Tower access and pad:

During the inspection on July 21, 2022 at the high point tower pad and access road there is a couple of concerns that was observed by the inspector.

There are a couple of soft spots along the access road that is getting to be a concern and may cause vehicles and heavy equipment to get stuck. The two areas are closer to the top of the access road that should be filled in to prevent a sink hole.

There was a crew from Arctic Foundations out of Winnipeg installing the condensers for the foundation. The crew was on their last day of work at the site. there was just a few little pieces of plastic trash around the work area and the crew leader Mike Watt indicated they will clean it up before they leave.

The rest of the site looked in good order.


