The clearance of Land Use Permit MV2004C0001 has been granted and our files are now closed as per section 33 of the Mackenzie Valley Land Use Regulations.

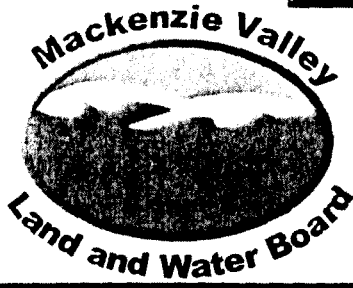
