The lab analysis submitted (L2330138 attached) shows a pH result of 6.61 for the sample taken at SNP-20, which is very close to the minimum pH value of 6.5 indicated in Condition 30 of Water Licence MV2005L2-0015. I would like to keep an eye on pH levels and request that the results from samples collected at station SNP-02 be forwarded directly to the Inspector as they become available. This can be done in the form of an email with lab certificate attached.
