Dear Mr. Paradis,

This letter is following the submission of the plan by the Giant Mine Directorate, in regards to the Jo-Jo Lake Remediation Plan submitted on August 2<sup>nd</sup>, 2011 and the proposed amendment submitted August 12, 2011.

After consideration of the plan and meeting with Fisheries and Oceans Canada, Environment Canada, Public Works and Government Services Canada and yourselves on August 12<sup>th</sup>, 2011 the decision has been made for supplementary information to be submitted. The information required is as follows;

- Monitoring and sampling plan down stream of Jo-Jo Lake during construction activities.
- Contingency plan that outlines, but is not limited to, emergency environmental response procedures.
- Provide a complete cap design including detailed information on the North side and West side of the cap including construction in that area to ensure cap integrity.
- Documentation on the possibility of enhancing drainage through the channel to the West to ensure capacity in the event of a high volume of water in this area.

This supplementary information is to be provided by September 6<sup>th</sup>, 2011 by 12:00pm.

Additional requirements for long term monitoring and any other post construction activities will be detailed in the letter of approval for this activity.
