**Complete Application, Renewal Type A Land Use Permit
Mining Exploration, Lac de Gras**

This acknowledges receipt of your Land Use Permit Renewal Application on March 17, 2011. The Mackenzie Valley Land and Water Board has determined that your application is exempt from Preliminary Screening under Paragraph 2 of Part 1, Schedule 1 of the Exemption List Regulations annexed to subsection 143(1) of the *Mackenzie Valley Resource Management Act* (MVRMA). The Mackenzie Valley Land and Water Board and staff will process your application as per section 22 (1)(b) of the Mackenzie Valley Land Use Regulations.

Within 42 days of the date of this letter, the Mackenzie Valley Land and Water Board will take one of the following actions:

1. Issue a Type A permit, subject to any conditions included pursuant to subsection 26(1);
2. Order, pursuant to subsection 24(1) of the *Mackenzie Valley Resource Management Act*, that a hearing be held or further studies or investigations be made respecting the lands proposed to be used in the land-use operation; or
4. Where a requirement set out in section 61 or 62 of the Act has not been met, refuse to issue a permit.

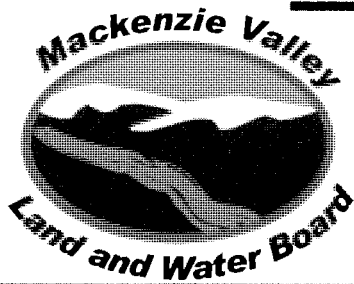
