Please submit the following information so MVLWB staff can consider the application complete and forward it for review:

1. The maximum amount of fuel to be stored on site at any one time;  
and
2. Under Section 6 of the Application Form, information specifically on the potential impacts on water and land.

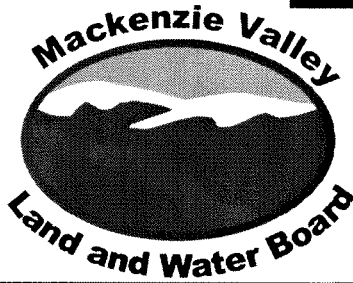
