Type A Water Licence Renewal Application**

As stated in the Board's letter of August 11, 2011, any claims for compensation will need to be made in accordance with section 14 of the *Northwest Territories Waters Act* (NWTWA). Also note that the Board's reasons for decision on past claims for compensation are available on the Board's Public Registry and may provide further guidance.

By way of example, the Board wishes to provide all parties with the names of two decisions in which the Board has made mention of the compensation issue. These decisions are:

MV2009L3-0007 - City of Yellowknife

MV2007L8-0025 - Miramar Northern Mining Ltd. (Con Mine)

Please be aware that these are not the only decisions in which the Board has discussed the issue of compensation under s. 14 of the NWTWA, nor does the Board wish to imply that the discussions in these two cases would necessarily have any bearing whatsoever on the Board's deliberations and decision in this case. The Board is simply offering this information to all parties. This letter and the Board's reference to these two decisions should not be taken as definitive of the compensation claim issue.

Each party must make its own case on the issue of compensation. It should also be noted that the Board is not bound to follow its previous decisions.

Please also note that the deadline for interventions, including any claims for compensation, is **September 2, 2011**.
