As discussed on the phone today, in order for this Extension Request to go out for review, Procore needs to engage with local first nations and inform them you are applying for the extension. This involves simply emailing a copy of the letter you sent to us notifying them that you are applying for the extension. Make sure to follow up with them to confirm they have received it, and then submit a log to me detailing the organizations you contacted, when contact was made, and confirming follow-up.
