### Purpose:

This technical session is meant to provide a forum where parties can discuss their concerns about the applications directly with the proponent and its consultants. It is the Mackenzie Valley Land and Water Board's (Board) and Parks Canada (Parks) hope that such a discussion, as facilitated by Board and Parks staff, will increase each parties understanding of the issues as well as of the perspectives of others. In our experience, technical sessions can be useful in reducing the number of outstanding issues between parties. Although it would be helpful if some issues are resolved during the session, there is no requirement to do so; Board and Parks staff will guide questions and discussions to ensure parties have sufficient information to submit evidence that the Board and Parks can use to establish eventual water licence and land use permit conditions. Discussions at the technical session may also reveal the need for information requests of the proponent or other parties. The work-plan for this review process includes time for parties to fulfill information requests, if required.

Please note that the technical session is not a public hearing; Board members and legal counsel will not be participating. It is the Board's and Parks wish that the technical session be as informal as possible in order to promote discussion. There will be an opportunity to submit final recommendations for the water licence and land use permit following a distribution of draft licences and permits that will occur after the Proponent has responded to information requests (if necessary).

Participants are encouraged to have questions prepared in advance for each topic and to take the opportunity to follow up on issues raised in the [Review Comment Table](#). Reference to specific items from the Review Comment Table is provided in the agenda below pertaining to issues raised during review. The focus of the technical session is to create appropriate conditions and associated schedules for the water licenses and land use permits for outstanding concerns.
