With your permission, I have dated the log December 12, 2020 (at the top, instead of November 28, 2015) so that it's clear this log has been updated. Otherwise, I've got everything I need to post the extension request for review, so will do that today or tomorrow. You should get an automatic notification from the ORS when it's distributed.

Unfortunately, because the extension application wasn't complete in time to process it and get the extension in place before the permit expires, I am going to have to ask you to apply for a storage authorization; this is essentially a placeholder between when the permit expires and the extension comes into effect.

The Storage Authorization Application Form is [here](#) and is quite short; there are no fees associated with this particular application. I'm copying the Dehcho Lands Inspector here so that she can confirm if there are any outstanding issues or concerns that would prevent the Board from issuing a Storage Authorization. This confirmation is required to process the application. It appears from the Engagement Log for the Extension Application that you've covered the bases in terms of engagement. There's no public review for the Storage Authorization Application; I will get this piece to the Board ASAP, once we hear from Danielle and you're able to send me back the application form.
