Issuance of Quarry Permit MV2016Q0024, Km 188.9, Highway No. 1 - Block 1 (a,b,c,d)

This letter is to inform you that the Government of the Northwest Territories (GNWT) Department of Lands is issuing a quarry permit at Km 188.9, Highway No. 1- Block 1 (a,b,c,d).

BACKGROUND

A quarry permit has existed in Km 188.9, Highway No. 1 since October 31, 2016 and the permit expired on October 30, 2019. The applicant is requesting 2,000 cubic metres of material from this location. It is important to note that the Department of Lands previously consulted on the quarry boundaries identified in this application on September 29, 2016, and these same boundaries are not proposed to change.
