The revised plan reflects comments provided to us on January 10, 2017, subsequent to the Mackenzie Valley Land & Water Board's (MVLWB) most recent review of submissions made by us in support of the Bullmoose-Ruth Remediation Project. Also, we have incorporated comments from the North Slave Metis Alliance that were submitted after the MVLWB's review period had ended. We hope that these revisions satisfy the MVLWB's requirements.

BULLMOOSE-RUTH REMEDIATION PROJECT

COMMUNITY ENGAGEMENT PLAN – REMEDIATION PHASE

1.0 Project Overview

The Bullmoose-Ruth (BMR) remediation project area is located approximately 84 km southeast of Yellowknife, NT, north of the Hearne Channel of Great Slave Lake. The area is comprised of 7 abandoned mine and exploration sites: Bullmoose Mine, Ruth Mine, Storm Mine, Joon Mine, Beaulieu Mine, Spectrum Lake Mine and Chipp Lake Mine. The sites are accessible through a historical ice road route or by float plane. All sites are located within a 30 km of each other.

The sites are within the asserted Akaitcho Territory and the Mówhì Gogha De Nītlèè (as defined in the Tlicho Agreement). The area is asserted as a traditional use area for Métis people of the Great Slave Lake area, represented by the Northwest Territory Métis Nation (NWTMN) and the North Slave Métis Alliance (NSMA). This revised Engagement Plan reflects the Remediation Phase of the Project and includes the South Slave and North Slave area Indigenous organizations as follows:

- Deninu K'ue First Nation (DKFN)
- Lutselk'e Dene First Nation (LKDFN)
- Yellowknives Dene First Nation (YKDFN)
- Fort Resolution Métis Council (FRMC)/Northwest Territory Métis Nation (NWTMN)
- North Slave Métis Alliance (NSMA)
- Tlicho Government

In addition to Indigenous organizations, INAC-CARD has identified other land users in the area, including private lodge owners, recreational users and mineral claim holders. As these parties may have overlapping interests with Indigenous organizations or may be Indigenous persons, engagement activities with them have been included in this Plan. Through engagement with specific groups identified in the Plan, INAC-CARD will simultaneously be providing information to the general public.

1.1 Site History

Exploration and mining operations began in the BMR area in the early 1940's and sporadically continued until the late 1980's.

Operations at Bullmoose Mine began in 1941 and were expanded in 1975. By 1987, the project was shut down due to lack of significant tonnage and lower than anticipated mill results. All infrastructure on the site was removed by winter of 1988.

Operations that occurred at Ruth Mine were minor in comparison to Bullmoose Mine, with only a few years of activity. Operations at Ruth Mine began in 1942, but only for 12 days before World War II halted operations. Production resumed in 1959 but was canceled by 1960 due to lack of funding.

Much like Ruth Mine, there were sporadic operations at the five remaining sites that mainly occurred during the 1940's and 1950's. These activities were mainly confined to channel samples and small-scale shafts.

2.0 Engagement Objectives

The objectives of the BMR Engagement Plan are to:

- Develop a BMR Project-specific Engagement Committee
- Facilitate community understanding of the BMR Remediation Project
- Facilitate community awareness of remedial planning and monitoring processes
- Facilitate Elders Committee participation in remediation and monitoring processes
- Exchange conventional scientific information and Traditional Knowledge regarding the BMR Remediation Project

3.0 Project Background

Phase I, II and III Environmental Site Assessments (ESA) have been conducted on all seven sites. Human Health and Ecological Risk Assessments (HHERA) were completed in 2014 and included information collected from the Traditional Knowledge (TK) Study conducted in 2010/2011. The Remedial Action Plan (RAP) was finalized in January 2016. The primary environmental concerns within the BMR area include soil contamination from tailings, acid rock drainage (ARD) and physical hazards such as open mine shafts, trenches, etc. The main concern from a human health perspective is the accessibility of the site. The area is accessible by snowmobile and frequented by those pursuing recreational and traditional wilderness practices, and thus the risk of exposure to the aforementioned environmental concerns.

4.0 Engagement History

Most of the community engagement for BMR occurred between 2010 and 2011, based on the Tlicho Agreement and the Akaitcho Interim Measures Agreement.

Community Engagement began in 2010 with a Weledeh (YKDFN) Dene Traditional Knowledge/Traditional Land Use Study that included a site visit. This was followed up in 2011 with a remedial options workshop and a third-party review of the RAP that was completed by ARKTIS Solutions Inc. on behalf of the YKDFN. There has been a gap in engagement since 2011 due to changes within the INAC-CARD Project Management Team (PMT), as well as competing needs of other INAC projects. However, community engagement continued in February 2015, with a remedial options workout and a project update meeting with YKDFN. Project updates were also provided to Lutselk'e (LKDFN), Fort Resolution (FRMC and DKFN) and Tlicho

community members, upon final draft of the RAP. Updates were also provided through the Waste Site Management Committee to the NWTMN and Tlicho Government.

5.0 Engagement Committee

Concerns over the BMR sites have been expressed throughout the engagement process and it is important that the interests of all parties are duly considered. An Engagement Committee will be formed that allows for an exchange of information and views from all parties, with smaller groups being formed for specified purposes. The members of these groups may be engaged individually or on an ad hoc basis, as required. The Engagement Committee membership will consist of:

- A. **Elders Committee**- As keepers of Traditional Knowledge (TK), Elders have a vested interest in the ecological health of the BMR Remediation Project area. Participating Elders will share their TK and concerns with the Elders Committee and report back to their community leadership. Committee membership will be drawn from the YKDFN, DKFN, LKDFN, FRMC and NSMA.
- B. **Lands and Environment Management Offices** - With mandates for land management within their respective areas, a Wildlife Environment Committee (WEC) and/or Land Protection Office (LPO) has a responsibility to communicate land use activities to its community members and leadership and other interested parties. Representatives will be selected within its organization and may include Technical Advisors as standing members. The WEC and/or LPO members will share information and concerns related to the BMR sites and report outcomes back to their leadership and members.
- C. **INAC-CARD Project Management Team** - Responsibility for overall project direction and decision making process rests with the site custodian, INAC-CARD. The PMT will provide technical information to the Elders Committee and incorporate shared information as part of their decision making process. INAC-CARD representatives have a responsibility to report BMR Project outcomes back to the Senior Manager for INAC-CARD and the National Director for the Northern Contaminated Sites Program.

6.0 Engagement Approach

The Project Management Team (PMT) will engage with the Lands and Environment Management Offices and the Elders Committee throughout all phases of the project. A previous engagement plan has been created for the planning phase of the BMR project. For a copy of this plan, please refer to the Mackenzie Valley Land and Water Board's Online Registry (<http://www.mvlwb.ca/Boards/MV/SitePages/search.aspx?app=MV2016X0013>). The current engagement plan describes the approach and activities planned for the remediation phase of the project, and a third plan will be created for the subsequent monitoring phase in 2019/20.

Community meetings and site tours have been held throughout 2016 and will continue for the duration of the BMR project. All activities have been and will be recorded in the Consultation Log (Appendix 3). Future engagement activities will include:

- i) "Round-table" meetings with Elders Committee members will provide a forum for equal, open discussions on project information. Meetings will be chaired by a selected Elders Committee member. Evaluations of meeting effectiveness will be accomplished through a feedback form to INAC-CARD. Based on evaluations, the engagement process will be continually improved.
- ii) Community project update meetings will provide an informal forum for any interested stakeholder to provide their views or ask questions to INAC-CARD. Open invitations will be advertised in the media, as well as provided to identified stakeholders well in advance of scheduled meetings. Any materials presented at such meetings will be also provided in advance, when possible. In addition to discussing matters at the meeting, INAC-CARD will work with individuals and communities after face-to-face meetings to ensure that any raised issues are resolved satisfactorily.
- iii) Information sharing between participants through distribution of minutes, recordings, pictures and other records with follow-up by INAC-CARD with designated community contacts to ensure that any comments or concerns are addressed.
- iv) Ceremonies and other cultural events to mark milestones in the remediation process (i.e. site blessings, opening ceremonies, closing celebration).
- v) Site tours to facilitate understanding of project components, surrounding environmental resources and the ecological/geographical context of the project locations. Site tour reports will be completed and shared with communities for the benefit of participants and community members who could not participate.
- vi) Developing and commissioning of commemorative plaque with communities at the end of remediation.

Upon request and at the convenience of groups involved in specific engagement activities, INAC-CARD may hold events jointly with other projects within its mandate. This is intended to ease "meeting overload" for participants and will be organized with the participation of the groups involved.

Translation services in Chipewyan or Tlicho will be provided when required.

7.0 Other Engagement

The Tlicho Government and NWTMN may be engaged through project updates during community meetings, formal letters and, where requested, site tours. Additionally, the involvement of the Tlicho Government and NWTMN with the Waste Site Management Committee established under the Devolution Agreement is a valuable form of engagement for the BMR Project. Other stakeholders such as government departments and non-government organizations will receive project information and updates as required.

Land users in the area will receive project updates through regular public meetings and written communications for critical information, such as updates on the BMR Winter Road program. Written communications will be used to provide information to users, but also to request feedback and provide contact information for where that feedback may be provided. All

feedback received from stakeholders will be responded to through direct contact with relevant parties by phone or email.

Engagement with other parties and dispute resolution may also occur through the regulatory review process under the Mackenzie Valley Land and Water Board.

8.0 Project Schedule

In addition to the activities listed in Table 1.0, other meetings, updates or site tours may be planned as needed or upon request of any group. If a group or individual requested more frequent or more detailed information to be provided on a certain topic, for example the winter road, INAC-CARD would make all reasonable efforts to ensure their request was accommodated. Unless otherwise indicated, all activities are with all groups, either separately or jointly.

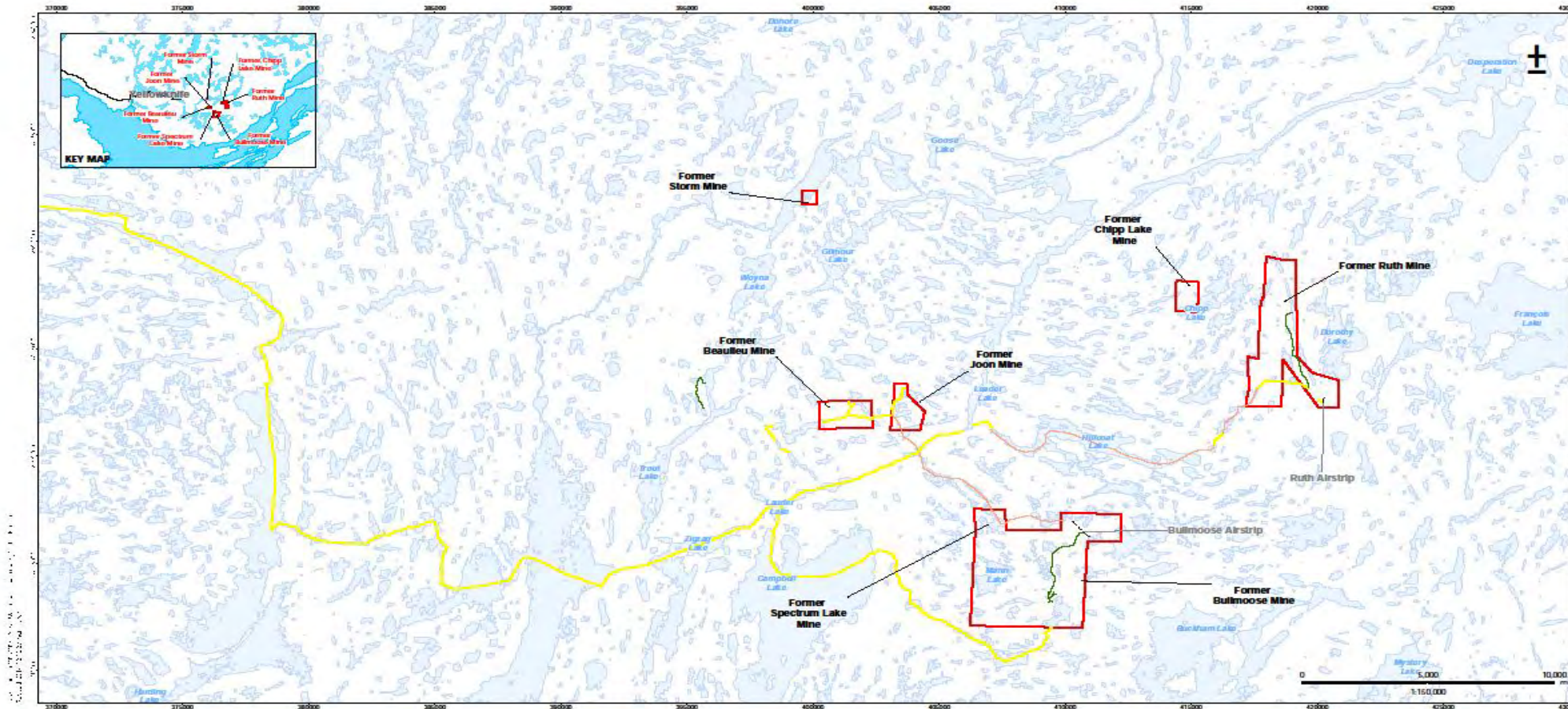

9.0 Budget and Resources

INAC-CARD will provide funding for engagement through a Contribution Funding Agreement (CFA). This funding will include transportation from participant's communities, private or commercial accommodations and meals (should attendance more than 1 day be required) as per the Treasury Board Guidelines, any facilities costs, and translation services as needed. Honoraria or Traditional Knowledge Elders Resources Funding will be provided to participants, based on parameters set out in individual CFAs or applicable Treasury Board guidance. Meetings will be held at mutually agreed upon dates and locations.

Consideration will be given on a case-by-case basis to INAC-CARD providing more resources, either through funding or training, to build capacity in communities. Increased capacity will assist communities in providing effective input to the remediation process.

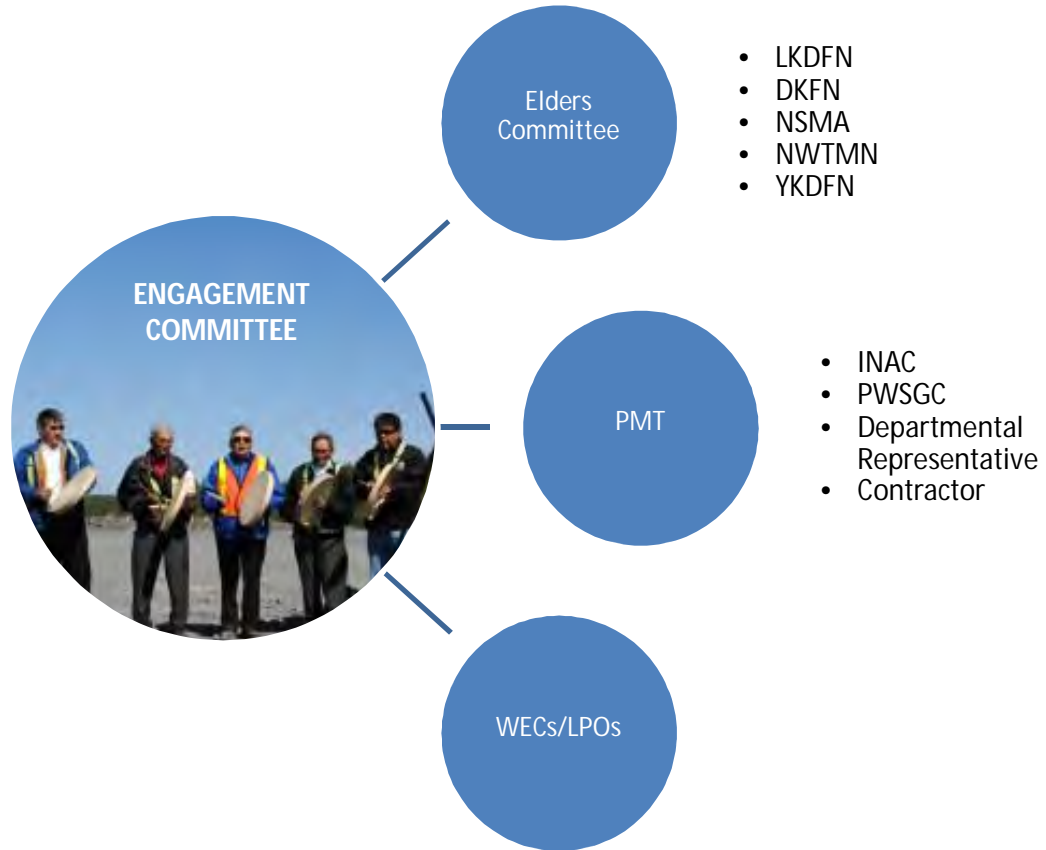
